GENERAL MEASURES FOR BEACH AND COVE ACCESS AND USE Bathing season from 1 June to 30 September

VINARÒS SAFE BEACH AND COVE CAMPAIGN ACT RESPONSIBLY FOR EVERYONE'S BENEFIT

Due to COVID-19, Vinaròs Town Council has had to take extraordinary measures in terms of access and use of the beaches in the town. These measures are the result of the regulations published by the Spanish Government and the recommendations from the Safe Beach Guide published by the Valencian Community Tourist Board.

All of the measures are linked to the hygiene, cleaning, maintenance, vigilance and information necessary to enable the beaches to be enjoyed safely and in a sustainable manner. ALL USERS OF THE BEACHES must comply with the measures set out by the competent authorities.

From Vinaròs Town Council we appeal to INDIVIDUAL RESPONSIBILITY IN COMPLYING WITH THESE MEASURES FOR THE BENEFIT OF EACH AND EVERY ONE OF US.

- 1. IF YOU HAVE SYMPTOMS that are compatible with a possible COVID-19 infection or if you have been in contact with an infected person, you must self-isolate until you receive instructions from the health authorities and YOU MUST NOT VISIT THE BEACHES OF VINAROS.
- 2. Two walkways have been set up at each of the entrances to the beaches El Fortí and Fora del Forat, one for entering and the other for leaving the beach, and they are signposted accordingly.
- 3. The first 8 metres from the seashore are reserved for access to the water and for beach users to walk in. Do not put down any towels, chairs, sunshades, loungers or any other objects that may hinder or prevent passage.
- 4. GROUPS OF MORE THAN 20 PEOPLE ARE PROHIBITED on the beaches in Vinaròs.
- 5. The social distance between beach users from different households must be at least 1.5 metres. RESPECT THIS DISTANCE AT ALL TIMES, BOTH ON THE SAND AND IN THE WATER, AS WELL AS WHEN MOVING AROUND. As a general measure, we recommend a distance of 4 metres between sunshades.
- 6. We recommend that you move around the beach as little as possible, so as not to breach social distancing measures.
- 7. Keep a close eye on children to ensure that they maintain a social distance of 1.5 metres, especially in the play areas on the beach.
- 8. We recommend that you bring hand sanitiser to the beach with you.
- 9. We want the beaches and coves of Vinaròs to be SMOKE-FREE AREAS, as cigarette butts pose a risk of infection and pollute the environment.
- 10. We recommend that you bring a bag to put all of the rubbish in that you generate during your visit to the beach and that you place it in the litter bins located at the exit to keep the beach free of litter and avoid unnecessary trips to the bin.



- 11. If you need to cough or sneeze on the beach, please use a tissue and immediately dispose of it in the rubbish containers or litter bins or keep it in a closed bag to dispose of later. If you do not have any tissues, cough or sneeze into your elbow.
- 12. We recommend that you wear flip flops in all areas of the beach, especially on the walkways and foot showers when able to use them.
- 13. We recommend that you do not play with items like bats, balls or frisbees so as not to interfere with social distancing and to prevent possible infection.
- 14. Strong winds may carry COVID-19; for this reason, increase social distances to more than 1.5 metres if the wind picks up while you are on the beach.
- 15. The FOOT SHOWERS may only be used when leaving the beach. After using them, we recommend that you clean your hands with hand sanitiser.
- 16. Beach volleyball is only permitted in the areas set up for that purpose. Litter bins have been placed at the access points to guarantee hygiene and ensure that the area is kept clean and tidy.

The lifeguards are at your disposal for your safety and to answer any questions or queries, as well as to ensure that these regulations are complied with. **WE ASK YOU TO FOLLOW THEIR INSTRUCTIONS**

Vinaròs Town Council reserves the right to apply the additional measures necessary for the regulations and recommendations set out by the competent authorities to be complied with, as well as to apply the corresponding sanctions.

INFORMATION ON BEACH AND COVE MAINTENANCE AND MEASURES IMPLEMENTED BY VINARÒS TOWN COUNCIL

- 1. The sand on the beaches will be cleaned every day using both mechanical and manual means.
- 2. All fixtures like handrails and walkways will also be cleaned.
- 3. Litter bins and containers will be emptied and disinfected daily.
- 4. Specific signs have been put up to inform users of the general measures for accessing and using the beaches.
- 5. Inspections are carried out to ensure that the capacity of the beaches is not exceeded and that social distancing measures are complied with. These measures will be adapted to the different de-escalation phases during the bathing season.
